TERMS AND CONDITIONS

Assignment. The Lessee shall not sublet the Equipment to another party.

Care of Equipment. The Lessee shall use the Equipment in a careful and proper manner. The Lessee shall notify the Lessor immediately when breakdowns occur and repairs are needed. The Lessee agrees to provide adequate cover to protect the Equipment when not in use during the rental period.

Repair of Equipment. The Lessor shall be responsible for all regular maintenance and normal repairs of the Equipment.

Loss and Damage to Equipment. The Lessee shall be responsible for loss or damage to the Equipment from any cause and agrees to return it to the Lessor in as good condition as when it was received, normal wear and tear excepted. The Lessee shall be responsible for the cost of repair or the cost of replacement for damaged Equipment at the Lessor's option.

Lessor's Right of Inspection. The Lessor shall have the right at any time to enter the premises occupied by the Equipment to inspect the use and care of the Equipment. If the Lessor determines that the Equipment is not being cared for or used properly, the Lessor may remove the Equipment from the premises.

Liability and Indemnity for Personal Injuries and Property Damage. Liability for injury, disability, and death of Lessee and other persons and liability for damage to property, real or personal, caused by the operation, handling, or transportation of the Equipment during the rental period shall be assumed by the Lessee, and the Lessee shall indemnify the Lessor and hold the Lessor harmless against all such liability.
